### BIOGRAPHY

Civil Engineer and Professor Luiz Otavio Beaklini joined Licks Attorneys in 2015 as a Patent Expert. As a fellow of several Brazilian delegations to the World Intellectual Property Organization (WIPO), Mr. Beaklini was an active member of the working group that set out both regulation and examination guidelines for the current Brazilian Patent Statute (Statute #9,279/96). In addition, he is a certified specialist in Intellectual Property by the WIPO and the United Nations Development Programme (PNUD).

As a professor, he teaches a course on Intellectual Property at UFF, one of the largest Federal Public Universities in the state of Rio de Janeiro, where he lectures since 1983. He was also a Visiting Professor at the George Washington University Law School (GW), focusing on Intellectual Property matters in 1997. Mr. Beaklini is a keynote speaker and authors numerous articles in the patent field in Brazil.
